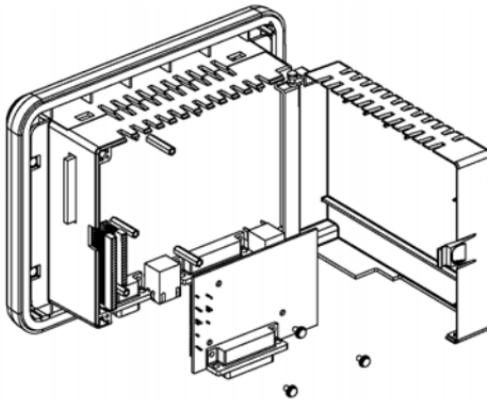

Note: The USB port on the DeviceNet interface card is not used when installed in the QuickPanel View or QuickPanel Control. The USB port on the card is not activated for maintenance or other application purposes and should not be connected.

Installing a Communication Module

Warning

Always use anti-static precautions when accessing the mating connector or the interior of the unit.



Note: The 6" model QuickPanel is shown. Other models are similar.

1. Disconnect the DC input power terminal block connector from your QuickPanel unit before inserting the Communication Module.
2. Open the back cover.
3. Attach the Communication Module to the unit by plugging the module into the mating connectors on the back of the unit.

Caution: Be sure to properly align pins in the dual connector upon insertion to avoid damage to the card or the QuickPanel unit.

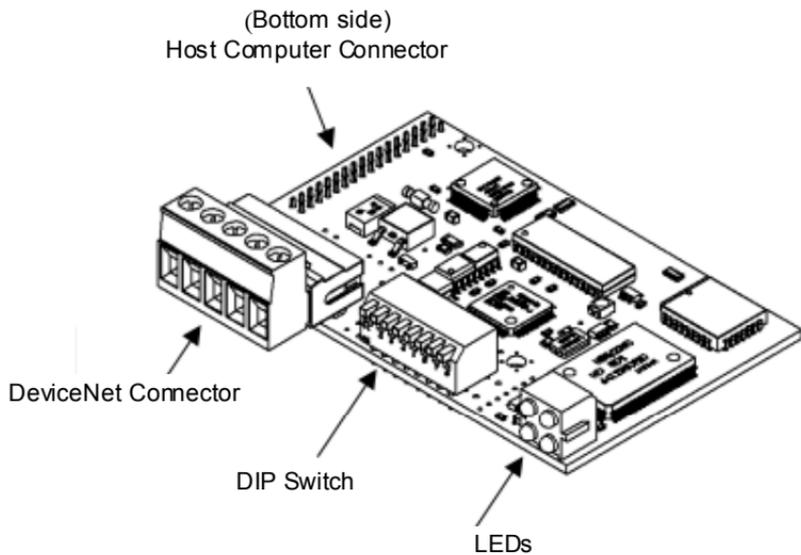
4. Install the three screws to secure the card in the unit.
5. Close the cover.

Note: To use this card with QuickPanel Control or View, Proficy® Machine Edition software is required. The Master card is supported in QuickPanel Control. The Slave card is supported only in QuickPanel View.

Overview

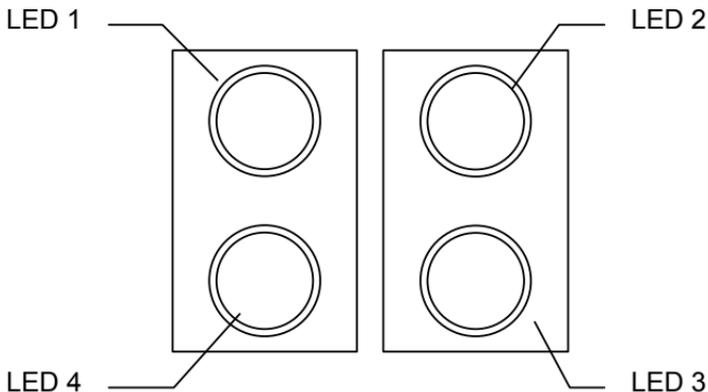
The DeviceNet module is shown on the next page. The host computer connector plugs into the expansion connector on the QuickPanel Control/View Operator Interface unit.

The DeviceNet connector provides communications via a DeviceNet fieldbus cable. DIP-switches are used to configure network baud rate and network address (MAC ID). The DeviceNet module has four LED indicators that display status.



Indicators

The DeviceNet module has four LED indicators that are mounted on the front of the module. There is also an additional on-board watchdog LED. These are used for displaying the status of the module.

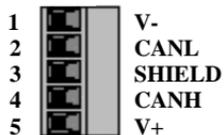

DeviceNet Network Connector

The DeviceNet FieldBus card has a 5.08mm, five-position screw connector. The pinout is as follows:

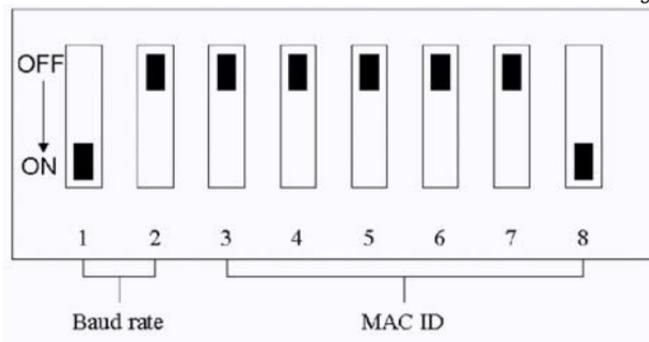
Configuration of Baud Rate and MAC ID

In a DeviceNet network, each node in the network has a MAC ID (the address in the network). The MAC ID is a number between 0 and 63. Each node's MAC ID has to be unique, since it is used to address the node.

In a DeviceNet network it is also possible to configure the Baud rate. The following Baud rates are possible to use in the network: 125, 250, and 500 kBit/sec. All nodes in the network have to communicate with the same Baud rate.

The MAC ID and baud rate are set by a DIP switch. The switch is mounted at the front of the module.

DIP switches 1 and 2 are used to configure the Baud rate and DIP switches 3 to 8 are used to configure the node address (MAC ID). The DIP-switch configuration is set according to the description on the next page.
